Electronic filing of case documents is mandatory for intellectual property cases as of November 1, 2007, and for all other civil cases as of January 1, 2008. Lawyers practicing in the Central District must be certified by the court and obtain a necessary password before the court will accept most documents submitted for filing. This program supplements the court's approved certification training, and will provide solutions to issues experienced by the court since the inception of the e-filing requirement.

Other topics include : support staff use of attorney certification, correcting filing errors, sanctions, varied filing hours, fees and much more.
